Background/Summary:

Each year, the terms of two-four members of the City's boards and commissions expire on June 30th. This year, the terms of 27 members of the City's boards and commissions will expire. In addition, there are two unexpired terms that need to be filled.

Administrative Assistant to the City Manager, Pattie McGuire, began advertising for board and commission openings on the City's website in March of 2014. During the 2014 application period, which ended on May 16, 2014, Pattie sent several reminders regarding board and commission openings through the website.

The total number of positions to be filled from new applicants and re-applicants is 29. There are 27 two-year and two one-year terms to be filled as follows:
