Item Title:

Background/Summary:

On June 23, 2014, members of City Council made appointments to fill a majority of openings on City Boards and Commissions. At that time, vacancies remained on the Cultural Arts Board (one partial term), Environmental and Sustainability Board (one partial term), and the LIFE Advisory Board (one full term). Shortly thereafter, the City became aware of two resignations which created vacancies of partial terms on the Cultural Arts Board and the Evelyn's Park Conservancy Board. Then, earlier this week, the City was informed of a resignation which created a vacancy of a partial term on the Board of Adjustment.


