#### **Background/Summary:**

Each May, the nation celebrates "Older Americans Month" in recognition of older Americans' contributions to their communities.

According to the U.S. Department of Health and Human Services Administration for Community Living, "Older Americans Month" was established in 1963. In April of 1963, John F. Kennedy, 35<sup>th</sup> President of the United States, met with the National Council of Senior Citizens and later issued a proclamation, which served as a prelude to designating May as "Senior Citizens Month."

In 1980, Jimmy Carter, 39<sup>th</sup> President of the United States, designated what was once called "Senior Citizens Month" as "Older Americans Month." Since that time, "Older Americans Month" has become an annual tradition. The theme for "Older Americans Month 2015" is "Get Into The Act."

#### Request for Proclamation:

In order to show the City of Bellaire's appreciation and acknowledgement of the contributions made by our older residents, Director of Parks, Recreation and Facilities Karl Miller, Assistant Director of Parks, Recreation and Facilities Cheryl Bright-West, and Recreation Supervisor Victoria Arevalo have asked Mayor Nauert to proclaim the month of May 2015 as "Older Americans Month" in the City of Bellaire, Texas.

Accordingly, a proclamation has been prepared for this purpose and is attached hereto. The L.I.F.E. At the request of the Chief of Police, Dr. Philip L. Whereas, May 15 is designated as Peace Officers Memorial Day, in honor of all fallen officers and their families and U.S. flags should be flown at half-staff;

#### A. Call to Order and Announcement of a Quorum - Dr. Philip L. Nauert, Mayor.

Dr. Philip L. Nauert, called the Regular Session of the City Council of the City of Bellaire, Texas, to order at 7:03 p.m. on Monday, April 6, 2015. He announced that a quorum was present consisting of all members of City Council as set forth in the table below.

#### B. Inspirational Reading and/or Invocation - James P. Avioli, Sr., Councilman.

James P. Avioli, Sr., Councilman, provided the inspirational reading for the evening.

#### **E. Personal/Audience Comments:**

#### Keith Bowers:

Mr. Bowers addressed City Council and indicated that the citizens of Bellaire had provided effective communication during the City's Community Meeting held the previous week. He stated that he hoped that City Council heard what the citizens had asked for.

The speakers were unanimous in their request that the Civic Center remain with City Hall and the Municipal Court be constructed by the Police Department.

Mr. Bowers urged City Council to listen to what the residents of Bellaire had asked them to do.

#### Robert Riquelmy:

Mr. Riquelmy addressed City Council and stated that he would like for the City to look at the City Clerk's example of courtesy and efficiency and use that as the basis for a course to train other City employees. He indicated that the City Clerk never failed to acknowledge a communication.

#### Lydia Caldwell:

Ms. Caldwell addressed City Council and stated that she had four main concerns with the May 27th Plan (developed by Architects PGAL) for the Bellaire Municipal Facilities Project. The concerns directly affected the quality of life for several current residents and many future residents of Aspen Street. The concerns specifically related to the building of the new Bellaire Police Department and Jail on the south side of Jessamine Street, locating them squarely back to back to Bellaire residences.

Ms. Caldwell continued and advised that her first concern was related to the security and safety of the residents of Aspen Street. She provided an example of an incident witnessed by her neighbor, Patricia Dunn, and noted that she had Ms. Dunn's permission to relay the incident to the members of City Council. Ms. Dunn witnessed a man running really fast up the driveway of the Police Department. The driveway was marked "Prisoner Transfer." A few seconds later, she witnessed a police officer running after the man and catching him. Ms. Dunn expressed concern that if the Police Building were located behind the Aspen Street residences, as proposed, the man running from the prisoner transfer area could have jumped a fence and taken a child, perhaps. Ms. Caldwell indicated that she guessed that the incident Ms. Dunn witnessed did not occur often, but the fact that it happened once, made it obvious that it could happen again in the next 50 years.

Secondly, Ms. Caldwell expressed concern regarding property values. She indicated that she had spoken with Betty Byrd, a long-time realtor, regarding the proposed location of the Police Building and Jail. Ms. Byrd had advised that having a Police Building and Jail directly behind a residence would most definitely decrease the residents' property values.

Thirdly, Ms. Caldwell expressed concern with having to endure more noise pollution than the residents of Aspen Street already had to deal with. The generator at the Fire Department would then have a building right across from it and, therefore, the noise would loudly reverberate between the two buildings. Of course, all the normal sounds having to do with the Bellaire Police Department would be even closer than before, including any time there were public protests and newscasts on the premises of the Police Department.

Ms. Caldwell's fourth concern related to drainage issues. After the new Fire Station was built, the owner of the two properties at South Rice Avenue and Aspen Street and Ms. Caldwell noted that they had a harder time draining their properties. Their backyards looked like lakes, then mud pits, for days following a rain. Building yet another massive building behind the residents could only add to the drainage issue. She did not believe the City of Bellaire wanted to negatively affect its residents.

In closing, Ms. Caldwell stated that she supported Alternate Plan A, which proposed building the new Bellaire Police Department and Jail on the north side of Jessamine Street. She urged City

Council to give her concerns due consideration as they moved forward in their decision process regarding the Bellaire Municipal Facilities Project.

#### Jeff Caldwell:

Mr. Caldwell addressed City Council and stated that he believed the Bellaire municipal facilities were currently right where they should be. The facilities had worked well in the existing locations for many years and were part of the feel of the City of Bellaire.

He asked City Council to remember that people did not move to the City of Bellaire because they thought everything felt wrong and needed to be rearranged. The feel of Bellaire was what had drawn a new generation to Bellaire and had kept the older generation from wanting to move elsewhere.

Mr. Caldwell advised that he understood fully that the facilities needed to be expanded and updated. There was absolutely no reason that the facilities should not be--in their current locations. Building a new and updated City Hall and Civic Center together made the most sense to him--as long as it was on South Rice Avenue across the street from the new Condit Elementary School. As far as the Police and Court facilities, if there was a concern about the perception of the Court and Police Department being in the same building, then constructing them in two separate buildings in the same location addressed that concern adequately.

Mr. Caldwell continued and reminded City Council that the Municipal Court Presiding Judge had discussed the importance of keeping the Municipal Court and Police near to each other. With respect to the Library, it was currently in the right place. The acquisition of the property to the west of the library allowed for expanded facility with a quiet and serene outdoor reading area, which was an activity that had made the Bellaire Library a place that parents wanted to bring their children again and again.

In closing, Mr. Caldwell urged City Council not to try and reinvent the wheel, but rather update and expand the facilities as needed in their current locations. He urged them to listen to the citizens of Bellaire. He urged City Council to honor the residents' knowledge and beliefs and to do what was right for the City of Bellaire now and into the future. He also cited his support for Alternate Plan A.

#### Lynn McBee:

Ms. McBee addressed City Council and stated that she was impressed and humbled by the informed, eloquent citizens who had spoken before City Council. She referred to the last item on City Council's agenda and indicated that the wording on seems a bit stilted and rigid to her. She suggested that City Council loosen it up a bit. Ms. McBee stated that City Council was asking Jeff Gerber, PGAL Architect, to analyze the plans (Alternates A, B, and C) as presented. She suggested that City Council also consider a combination in order to give Jeff Gerber the ultimate flexibility. She urged City Council not to box Jeff Gerber in.

Ms. McBee continued and urged City Council to consider keeping the Civic Center and City Hall together. One could interpret the moving of the Civic Center and its occupant seniors and their programs as an underhanded kick. She indicated that this was a mistake. The seniors had put in decades of service to the community.

In closing, Ms. McBee urged City Council to hold a Workshop Session and a Special Session to allow comments from residents before deciding what to adopt and approve. She noted further that Workshop Sessions were not generally covered by audio and video. She asked City Council to ensure that the Workshop Sessions are covered at least by video.

#### F. Report(s):

City Manager's Report dated April 6, 2015, regarding Bellaire parks plans and activities for summer 2015, and the schedule for board and commission interviews and appointments.

Paul A. Hofmann, City Manager, presented the City Manager's Report dated April 6, 2015, regarding Bellaire parks plans and activities for summer 2015, and the schedule for board and commission interviews and appointments.

The following outline of activities was presented:

April 11, 2015 - Trolley Run (scheduled to begin at 7:30 a.m.);

April 18, 2015 - Second Trolleywood Movie - Big Hero Six (scheduled to begin at approximately 8:00 p.m.)

April 25, 2015 - Wine & Tapas Event (scheduled to begin at 6:00 p.m. on the Great Lawn). It was noted that this event was organized by the Patrons for Bellaire Parks;

May 1, 2015 - Concert in the Park Series (First Concert, with three more concerts scheduled on the Saturdays following May 1, 2015). It was noted that the Southwest News and Tradition Bank were sponsoring the concert series;

May 2, 2015 - Pop-Up in the Park Event (scheduled to begin at 11:00 a.m. in Evelyn's Park). It was noted that this event was organized by the Evelyn's Park Conservancy Board; and

May 9, 2015 - Bellaire Family Safety Day and Health Day (scheduled from 10:00 a.m. until 2:00 p.m.). It was noted that this event was sponsored by the Bellaire Fire and Police Departments and the Houston Methodist Primary Care Group.

With respect to park improvements, City Manager Hofmann referenced recent improvements to Evergreen Park including an ornamental fence, re-landscaped areas, and irrigation system. He advised that the Therapy Pool had a problem with its salt system and that repairs had been made. Additionally the wrought iron fence around the pool had been repainted; concrete repairs to the entrance and patio deck were underway; and an eight-foot cedar fence had been constructed around the pump/filter/chemical area.

The fence at Ware Family Park had been replaced with an attractive ornamental fence. The fall surface was replaced and the play structure rehabilitated at Joe Gaither Park.

At Russ Pitman Park, new parking lot lights would be installed before the start of summer. New fencing would also be installed at Russ Pitman Park. Rehabilitation work similar to that performed at Joe Gaither Park was scheduled for Lafayette Park.

With respect to Mulberry Park, a new fall surface was installed. The City was also working with Bellaire Little League to enhance the softball field. At the Bellaire Family Aquatic Center, the handicapped lift had been replaced and was working and the door to the acid room had been replaced. Prior to the start of pool season, the play apparatus at the Bellaire Pool would be repainted, tiles and canopies would be replaced, as well as signage.

The last of the beautification funds provided by City Council this fiscal year were used to plant Asian Jasmine on the esplanade on South Rice Avenue between Bellaire Boulevard and Bissonnet Street. Seasonal color was also added on Bellaire Boulevard, and the tennis windscreens were replaced at Mulberry

Bellaire, and Feld Parks.

Pool operations were noted to have been restructured to put new emphasis on lifeguard training and supervision. A new lifeguard in-service training program with a focus on training, skills, and general customer service would be implemented, as well as a new lifeguard uniform policy and scheduling software. It was noted that Bellaire Pool would be opening on May 9, 2015.

In closing, City Manager Hofmann referred to a report City Council had received from the City Council regarding the status of applications and applicants for City boards and commissions. The current deadline for applications was noted to be May 1, 2015. As it stood currently, there were no agenda items scheduled for Monday, June 15, 2015. The City was targeting that date for conducting candidate interviews. It should work assuming the City Council continued the practice of only interviewing those applicants that had not previously served on the board that the applicant was applying for. He noted that since June was a five-Monday month, there was a little flexibility for additional interview times. It was anticipated that City Council would make board and commission appointments on July 6, 2015.

Mayor Pro Tem Nathan asked for an analysis on the financial and logistical implications on the three alternate municipal facilities site plans presented by John Gabriel on March 30, 2015 (including impact to trees and adequacy of parking). She also asked that Jeff Gerber not be bound by the three alternate site plans if he had other ideas to bring forth.

She also indicated that she would be interested in hearing from Chief Holloway as to how noise could be abated, as well as how to address issues related to the transfer of prisoners into the jail facility [as stated by a resident during personal/audience comments] if the Police Department ended up on the south side of Jessamine Street.

To the extent that it would make sense cost-wise to recombine the Police Department and Municipal Court, Mayor Pro Tem Nathan advised that she would be willing to entertain that option.

She stated that she would also like the City Attorney's guidance as to how to address issues with the alternate plans during the next election (i.e., if the Municipal Court reconstruction were to be delayed and if a new library were constructed).

[Also of note were educational materials distributed during the last election related to the bond program which sent a message as well-replacing versus renovating-that would need the City Attorney's review].

#### **Councilman Gus E. Pappas:**

Councilman Pappas noted that the Ad Hoc Municipal Facilities Committee had done a great deal of work on this issue, had asked the same questions that the public had raised on March 30<sup>th</sup>, and were in tune with the public sentiments. He urged City Council to let the Ad Hoc Municipal Facilities Committee provide their input and reincorporate their input back in the process before holding another Workshop Session.

#### Councilman James P. Avioli, Sr.:

Councilman Avioli indicated that he concurred with the statements made by Councilmen McLaughlan and Pappas. He noted that when City Council toured the facilities of other cities, the police departments and municipal court were located in other sections of the city and not necessarily adjacent to city hall. He suggested that City Council not overlook anything this time around and noted that there was a police dispatch station (owned by the City of Houston) across the road from City-owned Recycling Center property.

From a business perspective, Councilman Avioli asked Jeff Gerber to explore an alternative plan that could be constructed for the City's budget of \$11 million.

#### Jeff Gerber, AIA, LEED AP, and CEO of PGAL:

In responding to a question asked by Councilman Roman F. Reed as to whether the cost of the alternate plans had been discussed, Mr. Gerber indicated that he suggested that determining the cost implications of the alternate plans would give the City a framework from which to make the best choice. Additionally, it seemed that a discussion with the Ad Hoc Municipal Facilities Committee regarding the objectives and a recommendation as to whether those objectives needed to be changed (i.e., added to or subtracted from). Mr. Gerber indicated further that it would be helpful to confirm in City Council's Workshop Session what they wanted the objectives to be. From there, discussions could be held as to how each of the alternatives lined up against City Council's objectives.

#### Councilman Roman F. Reed:

Councilman Reed stated that whether City Council selected the site plan that was previously unanimously adopted by City Council or whether a new alternative site plan were selected, the difference in costs needed to be stated. He stated further that citizens had indicated to City Council that they were willing to pay increased taxes to support additional costs that might be incurred as a result of an alternate plan.

#### **Councilman Andrew S. Friedberg:**

He indicated that the item on City Council's agenda was the natural result of the March 30<sup>th</sup> Community Meeting. City Council had heard the public input. He suggested that instead of worrying this evening as what would be talked about during the Workshop Session, he was prepared to move forward with this item as discussed and amended. He looked forward to a Workshop Session and felt that City Council could revisit at that time the extent necessary for more direct involvement by the Ad Hoc Municipal Facilities Advisory Committee as it existed now.

#### Mayor Philip L. Nauert:

#### **Background/Summary:**

Deputy Court Clerk Rosivel Reyes of the Municipal Court of the City of Bellaire, Texas, voluntarily ended her employment with the City of Bellaire, Texas, on November 21, 2014. This vacancy/position was subsequently advertised and filled by Chief Financial Officer Linda Symank, along with Municipal Court Clerk Belinda Flores.

As you are aware, Article II, Council, Section 14, Municipal Court, of the Charter of the City of Bellaire, Texas, as amended November 7, 2006 (the "Charter"), includes provisions for the appointment by City Council of applicable municipal court personnel including a judge and such other associate judge or judges as shall be determined necessary, as well as for the appointment by City Council of a clerk and as many deputy clerks as shall be determined necessary.

On August 4, 2014, at the recommendation of the Finance Department of the City of Bellaire, Texas, City Council adopted Ordinance No. 14-039 for the purpose of reappointing, in their current capacities, the then Court Clerk (Belinda Flores) and Deputy Court Clerks (Evetta Herbert and Rosivel Reyes) effective August 4, 2014, for a term that would not expire unless said Court Clerk or Deputy Court Clerks voluntarily ended her appointment or were removed from her appointment by action of the City Council.

#### **ORDINANCE NO. 14-058**

AN ORDINANCE- OF THE CITY COUNCIL OF THE CITY OF BELLAIRE, TEXAS, APPOINTING SEVEN (7) MEMBERS TO SERVE IN AN ADVISORY CAPACITY ON THE AD HOC MUNICIPAL FACILITIES COMMITTEE OF THE CITY OF BELLAIRE, TEXAS ("COMMITTEE"), FOR A TERM COMMENCING ON OCTOBER 20, 2014, AND ENDING ON SEPTEMBER 30, 2015; SETTING FORTH THE CHARGE OF THE COMMITTEE, AND APPROVING A WORK PLAN FOR THE DESIGN OF NEW MUNICIPAL FACILITIES.

WHEREAS, on May 6, 2013, the City Council of the City of Bellaire, Texas, engaged the firm of Pierce Goodwin Alexander & Linville (PGAL) to provide professional services necessary for Municipal Building Concept Design Studies for the City of Bellaire, Texas, focusing on the City Hall, Civic Center, Police Station, and Municipal Court Buildings; and

WHEREAS, the voters of Bellaire approved a municipal facilities bond program in November of 2013, which will provide \$11,000,000.00 for the purpose of improving, repairing, constructing or replacing certain municipal buildings and facilities, to wit: City Hall, Civic Center, Police Station, and Municipal Court Buildings; and

WHEREAS, on May 27, 2014, the City Council of the City of Bellaire, Texas, approved and adopted a recommendation from PGAL to adopt the "Campus of Buildings" municipal facility configuration option for the development of the City Hall, Civic Center, Municipal Court Building, and Police Station; and

WHEREAS, the City Council of the City of Bellaire, Texas, is authorized to create an ad hoc committee for specific advisory purposes where such existence is limited to a period of less than one (1) year; and

WHEREAS, the City Council of the City of Bellaire, Texas, heretofore previously established an ad hoc committee, hereinafter referred to as the "Ad Hoc Municipal Facilities Committee," on September 8, 2014, to serve in an advisory capacity regarding the development of municipal facilities; and

WHEREAS, the Mayor asked members of City Council to each appoint one (1) citizen of the City of Bellaire, Texas, to serve on the Ad Hoc Municipal Facilities Committee, with the Mayor appointing one (1) citizen and selecting the member of City Council to serve as Council Liaison to the Ad Hoc Municipal Facilities Committee; and

WHEREAS, on September 22, 2014, the City Council of the City of Bellaire, Texas, entered into a contractual agreement with PGAL to provide architectural and engineering design services for the municipal facilities, hereinafter referred to as the "Municipal Facilities Project"; NOW, THEREFORE.

# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BELLAIRE, TEXAS, THAT:

- 1. The recitals set forth above are true and correct.
- 2. The Ad Hoc Municipal Facilities Committee shall be composed of the following seven (7) persons and are each hereby appointed by action of the City Council of the City of Bellaire, Texas, for a term commencing on October 20, 2014, and ending on September 30, 2015, as practicable, unless sooner terminated or extended by action of the City Council of the City of Bellaire, Texas:
  - a. Charlotte Aguilar, selected by Dr. Philip L. Nauert, Mayor;
  - b. Dolores Avioli, selected by James P. Avioli, Sr., Councilman;
  - c. Christopher Butler, selected by Amanda B. Nathan, Mayor Pro Tem;
  - d. John Gabriel, selected by Pat B. McLaughlan, Councilman;
  - e. Chris Kaitson, selected by Gus E. Pappas, Councilman;
  - f. Kristin Schuster, selected by Andrew S. Friedberg, Councilman; and
  - g. Suzanne Shelby, selected by Roman F. Reed, Councilman.
- 3. Councilman Gus E. Pappas is hereby appointed as Council Liaison to the Ad Hoc Municipal Facilities Committee.
- 4. The Ad Hoc Municipal Facilities Committee is hereby charged to develop consensus recommendations to the City Council of the City of Bellaire, Texas, limited to the following:
- a. Impact of construction on the park facilities, and more specifically the Great Lawn, located in Bellaire Town Square, and development of an approach or proposal to address possible impact(s).
- b. Review of a conceptual design for a possible signature corner for Bellaire Town Square and the park and municipal facilities therein, as well as the development of a proposal for the elements to be included on said signature corner.
- c. Review of a conceptual design for a pedestrian-friendly median along South Rice Avenue, as well as the development of a proposal for said median.

- d. Provide definitions for various campus elements.
- e. Provide direction and an approach related to the style of architecture for each municipal facility, including exterior and interior finishes.
- f. Review of overall LEED (Leadership in Energy and Environmental Design) approach for said municipal facilities and provide direction therein.
- 5. The Ad Hoc Municipal Facilities Committee meetings will be posted and held in accordance with the Texas Open Meetings Act and facilitated by the City's architectural and engineering firm, PGAL.
  - 6. The role of the Council Liaison is hereby established as follows:
- a. Assist in communicating the recommendations and overall progress of the Ad Hoc Municipal Facilities Committee to the City Council of the City of Bellaire, Texas;
- b. Assist the City Manager and PGAL with the receipt and assimilation of community input;
- c. Assist the City Manager and PGAL with the receipt and assimilation of input from the Cultural Arts Board of the City of Bellaire, Texas, and from the Evelyn's Park Conservancy Building Committee; and
- d. Assist the City Manager and PGAL with the publication of updates and narratives for public information.
- 7. The initial project timeline, including the initial schedule for Ad Hoc Municipal Facilities Committee meetings, City Council Workshop Sessions, and significant publication dates is hereby established in the Work Plan as attached hereto and marked Exhibit "A."
  - 8. This Ordinance shall be effective immediately upon its passage and adoption.
