He mentioned that staff is also still trying to take care of the flood damaged homes. Mr. Cabello then stated that this will be his last meeting due to the fact that he is retiring on September 18th. He added that he has enjoyed working for the City of Bellaire and thanked the Commission for their service and what they do in order to better the City.

Commissioner Baker thanked Mr. Cabello for his service and asked about the number of permits that resulted from the Memorial Day flooding. He questioned how many permits are outstanding and how many new ones have come in since the last meeting.

Ms. Sampson, Development Services Manager, informed the Commission that there are still some flood permits coming in, and she believed that one is outstanding. She stated that she will make sure that the Commission gets those numbers at the next meeting.

2. Discussion and review of the City of Bellaire Code of Ordinances, Chapter 9, Buildings, Article I, In General, Section 9-5, Duty of contractors and other persons performing construction work within the city, with regard to chain-link fencing with silt protection.

Chairman Thurmond explained that she had added this to the agenda so that the Commission could discuss options on how to enforce the ordinance that had been put in place.

Mr. Cabello informed the Commission that the inspectors will start leaving red tags on sites where the silt fencing is not properly installed.

Vice Chairman Spencer pointed out that many of the builders do not know how to properly install the silt fencing and suggested that the Commission better educate them on what storm water pollution prevention is. He mentioned that he had spoken with a company called Environmental Allies that were willing to come in and hold a lunch and learn for the builders in order to help them to better understand the requirements of the ordinance and the expectations of the City. Vice Chairman Spencer stated that the head of the Houston Building Inspection Agency's storm water department would also be willing to help.

Chairman Thurmond asked what the best way would be to get the builders committed to joining the Commission for the lunch and learn.

Mr. Cabello stated that an email can be sent to all of the builders.

3. The Chair shall recognize any Commissioner who wishes to bring New Business to the attention of the Commission. Consideration of New Business shall be for the limited purpose of determining whether the matter is appropriate for inclusion on a future agenda of the Commission or referral to Staff for investigation.

No New Business was brought to the attention of the Commission.
