#### E. Personal/Audience Comments.

#### **Robert Riquelmy:**

Mr. Riquelmy addressed City Council and advised that he wished to continue on a topic he had raised at the last City Council Regular Session, which was the topic of openness and transparency.

Reference was made to the term "lobbyist." Mr. Riquelmy advised that the term "lobbyist" was derived from the act of approaching a legislator in the "lobby" to plead a case. He indicated that this did not happen in Bellaire because the legislators were hidden in the back room prior to the meeting. If elected Mayor, Mr. Riquelmy stated that the corrals, fences, and gates would be adjusted so that the legislators were forced to be in the lobby before the meetings so that they would be available to the citizens to "lobby," as they should be, in his opinion.

#### Lynn McBee:

Ms. McBee referenced City Council and announced that the Bellaire Election Candidates Forum ("Forum") would be held in the Civic Center (auditorium) on Thursday, October 15, 2015, at 6:30 p.m. Ms. McBee advised that the entire community was invited to attend and hear all candidates. She noted that the Forum would not be televised "live," but would be replayed after the event occurred.

Secondly, Ms. McBee urged City Council not to create booze in the park (Evelyn's Park). She believed that it would be the forerunner of many other abuses that all of the community was paying the price for, such as overmedication, DUIs (driving under the influence), chaotic driving, and chaotic acts of violence. Once the precedent of "no alcohol in the parks" was violated, the City would pay a price in her opinion. She urged City Council not to tap into a restaurant providing beer and wine for more profits for the Evelyn's Park Conservancy ("Conservancy") to use to pay the bills.

Reference was made to the Conservancy, which was created with the promise that private funds, grants, and foundation funds, would fund the park. Ms. McBee advised that this was not significantly true. The City now had restaurants to make money and alcohol to pay the way.

#### **Barbara Jerige:**

Ms. Jerige addressed City Council and indicated that she had a prepared statement to read into the record. The statement has been transcribed in its entirety as follows:

- We bought in Bellaire because it was advertised as a "City of Homes," where we wouldn't be around businesses, so that we could protect the financial investment we were making in our home.
- We chose our particular home because of the beauty and peacefulness of the neighborhood.
- The lots where Evelyn's Park is located were zoned as Residential.
- Before we bought our home, we were told that Evelyn's Park would be a tranquil, peaceful and beautiful sanctuary with walking paths and water.
- There <u>was</u> peace and tranquility in our neighborhood until Evelyn's Park events and construction began.
- Evelyn's Park events have been anything <u>BUT</u> peaceful and tranquil.
- The latest event for groundbreaking sounded like people were playing Bingo with a megaphone right outside our bedroom window while we were trying to sleep.
- Before we bought our home, we were told that the café would be open for Park events only.
- After we bought our home, we found out that the café is now going to be a fulltime restaurant that will be open for breakfast, lunch, and dinner 7 days a week.

- Now the Bellarie City Council is being asked to vote on approving a BAR right behind our home that will be open 7 days a week until 11:00 p.m.
- What happened to the promise that Bellaire is the City of Homes?
- We are not in Mid-Town, the Heights, the Theater District, the Museum District, or downtown Houston.
- We are in Bellaire, the City of Homes.
- If this were your home and your neighborhood, would you want a Bar that is open 7 days a week until 11:00 p.m. right behind your home?
- Why did the Evelyn's Park Conservancy promise to be a good neighbor and then turn around and request a full-time Bar on a blanket basis for the restaurant and events?
- How is this being a good neighbor? This feels more like a bait and switch.
- Would the members of the Conservancy have the same opinion if they lived in my home and in my neighborhood that backs extremely disruptive Evelyn's Park events and now potentially a BAR?
- What opinion would you as the City Council and the Mayor have if you lived in my home and in my neighborhood that backs extremely disruptive Evelyn's Park events and now potentially a BAR?
- I am requesting that as you vote on this, that you do so with your own moral conscience and convictions and not with politics in mind.
- I ask that you vote the same way that you would vote if you lived in my home and in my neighborhood that directly backs Evelyn's Park.
- If there is a number of Bellaire residents who want a full-time Restaurant and Bar in Bellaire, then that Restaurant and Bar should be built on a lot that is already zoned for business, not on a lot that was zoned residential that is in the middle of a beautiful and otherwise peaceful and tranquil neighborhood.
- Again, I respectfully ask, "What happened to Bellaire, the City of Homes?"
- We are already extremely concerned about the negative impact that Evelyn's Park Events and the Restaurant may have on both our property value and the quality of life in our home and in our neighborhood.

- We are horrified at the Conservancy's request to now add a BAR right behind our home.
- We are respectfully asking that you please vote NO to the Conservancy's request.
- Please know that we are committed to protecting our neighborhood's beauty and peacefulness, as well as our large financial investment in our home and property.

#### **Andrew Jerige:**

Mr. Jerige addressed City Council and echoed his concerns about Evelyn's Park becoming what was looking like "Evelyn's Bar and Grill." He did not believe that Evelyn would want a park named after her to be a late night bar in the middle of Bellaire. Mr. Jerige advised that he did not want a bar at Evelyn's Park serving alcoholic beverages to the general public until 11:00 p.m.

He continued and advised that he did not wish to see intoxicated people driving up and down the streets of Bellaire and in our neighborhoods. Almost all of the parks Mr. Jerige had visited in Texas did not allow alcoholic beverages in the parks. He expressed concern related to alcohol and accidents, children observing intoxicated persons, and the possibility of litigation related to injuries that could occur as a result of alcohol use.

In closing, he asked City Council for the status of the construction of a wall between Evelyn's Park and the residents living on the south side of Camellia Lane.

#### Michael Fife:

Ms. Fife addressed City Council and complimented the Rubenstein family for their generosity of giving the property for Evelyn's Park to the City of Bellaire in honor of their mother, a very special person. She stated that she was not completely opposed to having beer and wine at the little bistro in Evelyn's Park.

Ms. Fife indicated that she wished for the restaurant hours to be appropriate for the neighborhood. She agreed with the Jeriges in that this was not Mid-Town, the Galleria, or Downtown. Most of the neighborhood restaurants in Bellaire and West University Place closed at 9:00 p.m., which was an appropriate time for a residential neighborhood restaurant. A special event on a Tuesday or Thursday night, for example, lasting until 11:00 p.m. was too loud and too much.

In closing, Ms. Fife stated that she hoped that the appropriateness of the neighborhood where Evelyn's Park was living would be under consideration.

#### **Brian Laviage:**

Mr. Laviage addressed City Council and advised that he sympathized with the residents that were opposed to alcohol in Evelyn's Park. He indicated that he supported the request for alcohol in Evelyn's Park as he believed that the service of wine and beer would drive the success of the park.

Additionally, Mr. Laviage believed that most of the traffic to/from Evelyn's Park would be walking traffic. For that reason, he was not terribly worried about drunk drivers.

#### Julie Malin:

Ms. Malin addressed City Council regarding wine and beer in Evelyn's Park from three

angles. She indicated that first she was the mother of a tween. The idea of a park where she could meet friends and watch her daughter play was wonderful. As part of a bunch of boards and different leadership in Bellaire, Ms. Malin saw the common sense and the responsibility that Bellaire, as a community, had.

In closing, Ms. Malin stated that she believed a restaurant that offered wine and beer was a recipe for success in Bellaire.

#### **George Perkins:**

Mr. Perkins addressed City Council and referenced the construction project that was currently ongoing on Evergreen Street by Total Contracting as a component of Phase Four improvements in Bellaire.

Initially at the beginning of the summer the residents of Evergreen Street received notification that they would have construction beginning at the start of summer and ending in August. Mr. Perkins advised that it was now the 21<sup>st</sup> of September, and the construction was nowhere near completion.

Within the past two weeks, he advised that there had been the necessary demolition of the northern side of the street in order to complete drainage, as well as replace drainage. However, none of the residents in that block of Evergreen Street had received timely notification of that process. Specifically, on the 8th of September, there was supposed to have been a notification delivered stating that on the 10th of September demolition would begin on the sidewalk and driveways, therefore, residents would not have access to their homes. On the 10th of September at approximately 1:00 p.m., at least two residents indicated that notifications were slipped retrospectively through their door with a date of September 8th.

The end result was that at least two residents had cars trapped on their driveways and could not exit at the time that they would normally leave to pick up children from school. Mr. Perkins advised that he had a brief conversation with some of the people on the site and telephoned the 24-hour notification service. The following day only Mr. Perkins' driveway was given a temporary bridge with a steel metal plate in order to allow access.

This week, Mr. Perkins prospectively received notification that the driveway access that had been formed would not be available, but the notice also stated that a temporary driveway would be in place by the end of the day. This was at a time when most of Texas was forecasting rain. A portion of the work was completed; however, from 5101 to 5108 Evergreen Street, there was no access and there had been no further construction.

Mr. Perkins' added that at least two of the Evergreen Street residents had asked for additional temporary driveways. The response they received was that it was not possible because if one person asked for one, everyone would ask for one.

Mr. Perkins' expressed concern that the City was undergoing a project that was well behind schedule and he hoped that there were negotiated penalties within the contract and, if present, fully executed. Residents were told they would have no access to their driveways for 14 to 21 days. For the last eight days, there had been no progress on the project. Further, the handicapped access had been removed and those with disabilities had to travel over rubble to get to their vehicles.

At present, construction had commenced on Fifth Street, which was the temporary parking for most of the residents on Evergreen Street. Evergreen Street residents had

to walk a minimum of a 1/4-mile to park along four-lane South Rice Avenue of which many people were uncomfortable due to traffic volumes.

Mr. Perkins' stated that this was unacceptable and that the City should hold the contractors and everyone else accountable.

I'm in support of beer and wine sales at Evelyn's Park.

I am in support of the new restaurant to be located in Evelyn's Park serving beer and wine. I look forward to being able to have a glass of wine while relaxing in the beautiful park. Thank you for supporting the proposed ordinance.

Vote YES to lifting the ordinance that prohibits alcohol in Evelyn's Park.

#### **Elyse Kalmans:**

Dear Council Members,

As a 15-year resident of Bellaire, I am completely comfortable and supportive of beer and wine served in the restaurant area of Evelyn's Park. Many other area parks, like Discovery Green and Memorial Park, are doing this successfully. I think it will increase attendance and revenues as well. Please vote YES for beer and wine in the restaurant area of Evelyn's Park.

#### **Marybeth Flaherty:**

On your agenda tonight, item G.2.a. asks for your approval of an ordinance allowing the sale and consumption of beer and wine in Evelyn's Park. I am writing this letter and requesting that it be read into the record for this evening's meeting.

As you know, I was on the original board of Evelyn's Park Conservancy and was on the board through the planning and design phase of the Master Plan and Phase 1. From the very beginning of discussions about the park, there has always been a desire to offer the community a place to gather and enjoy not only the outdoors and nature, but also to offer a cafe/event venue where food and beverages could be enjoyed in the beautiful setting of the park.

At previous Council meetings when discussion of the cafe took place, many of you currently on City Council acknowledged that sitting under the trees outside the cafe with a meal and glass of wine would be quite nice. I hope that you will tonight vote to approve the adoption of an ordinance that will allow adult visitors to Evelyn's Park the opportunity and the choice to consume beer and wine on the property in the designated area.

#### **Phebe Chen:**

Yes to allowing alcohol in Evelyn's Park.

#### **Cynthia Siegel:**

Dear Mayor Nauert and Bellaire City Councilmen:

I am writing to request your approval of amending Chapter 3, Alcoholic Beverages, in the Bellaire Code of Ordinances to allow for the consumption of wine and beer at the new restaurant being built in Evelyn's Park.

I understand that some residents might be concerned that the sale of alcohol may lead to drinking in other parts of the park outside of the restaurant facility and designated outdoor restaurant space. First, I know how strict restaurants are in general and careful about keeping people from taking drinks outside of their facilities in fear that they would lose their liquor license. There is no reason to believe that this restaurant operator would be any different and risk their license after the significant investment they will make to get the restaurant up and running in the park by not taking steps to ensure that alcoholic beverages aren't taken outside of the designated space. Additionally, besides the strictness of the State and City statutes, Bellaire police can be called if there are any problems--alcohol related or other, when the Conservancy can't be reached.

To my knowledge there has not been any problems with other restaurants that serve wine and beer in Bellaire where people take the alcoholic beverages outside of the facility. The success of this restaurant and its revenue payments to the Conservancy are critical to providing quality maintenance/improvements (above what the City will provide) and programs within the park. To not allow the sale of wine and beer within the restaurant, adjacent indoor event space and designated restaurant outdoor space during **reasonable** business hours would increase the chances dramatically that the restaurant would have a hard time being successful.

I believe that the Conservancy and Bellaire City Council can work together to put in place safeguards that would address the neighbors' concerns related to the sale/use of wine and beer at restaurant event space. I encourage you to pass this amendment to the ordinance.

Dear Mayor Nauert and City Councilmen:

On your agenda tonight, item G.2.a. asks for your approval of an ordinance allowing the sale and consumption of beer and wine in Evelyn's Park. I am writing this message and requesting that it be read into the record for this evening's meeting.

I approve of the agenda item relating to sale and consumption of beer and wine in Evelyn's Park and am ok with it being allowed until 11 pm.

#### F. Reports:

City Manager's Report dated September 21, 2015, regarding the condition and planned assessment of the Public Works Service Center - Submitted and presented by Paul A. Hofmann, City Manager.

**Paul A. Hofmann, City Manager**, presented the City Manager's Report dated September 21, 2015, to members of City Council. The report consisted of a condition and planned assessment of the Public Works Administration Facility

("Facility") located at Baldwin and Edith Streets.

Reference was made to the Memorial Day flood event, which caused damage to the Facility. During a recent Facility update provided by City Staff, it was noted that the City's plan was to fix the Facility back to its existing condition using insurance proceeds. Also during the update, City Council was told that City Staff would return and ask for a construction contract to be awarded.

After continuing to assess the situation and after obtaining more information, the plan had changed. City Manager Hofmann suggested that the City take a step back and more fully think through all of our options.

At this time, the City had not identified a feasible plan for dealing with the chronic flooding issues at the Facility. The City was still in discussions with the Federal Emergency Management Agency ("FEMA") regarding one particular approach to mitigating the flooding for the Facility and the area around the Facility. The cost of that particular approach was prohibitive.

Also of note were Americans with Disabilities Act ("ADA") issues that needed to be addressed in the repair of the Facility. At this point, the City believed that some expert analysis was needed to address the issues.

City Manager Hofmann advised that funds were budgeted in the next fiscal year's budget to perform some public works administration assessment work. The City might add to the scope a bit to more fully look at the ADA issues. The City would also continue working with FEMA. The City was not sure, at this point, that the best long-term plan was to repair the Facility at its current location.

In closing, City Manager Hofmann stated that he did not think it would take long to come back to City Council with some well thought out options for consideration.

Although the current working conditions were not optimal, but City Staff was making do. It was noted that some of the staff were utilizing the Fire Station and others were still at the Facility.

**Dr. Philip L. Nauert, Mayor**, opened the floor for questions of City Manager Hofmann regarding his report.

Following questions, Mayor Nauert called for a motion to accept the City Manager's Report into the record.

**Karl Miller, Director of Parks, Recreation and Facilities**, summarized the agenda item before City Council. The agenda item consisted of a request

from the Evelyn's Park Conservancy requesting City Council support for the sale, service, and consumption of beer and wine in the designated area in Evelyn's Park.

It was noted that the Development Agreement between the Evelyn's Park Conservancy ("Conservancy") and the City identified that City Council would need to amend Chapter 3, Article I, by revising Section 3-3, of the Code of Ordinances of the City of Bellaire, Texas. Such amendment would allow the consumption and sale of beer and wine without requiring the Conservancy to come to City Council seeking a special use permit each time an event was held, for example.

Director Miller advised that City Staff had measured from the location of the cafe door to the closest door at the Bellaire Methodist Church across the street. That distance did exceed the required 300 feet identified in Chapter 3, Article I, Section 3-2, of the Code of Ordinances of the City of Bellaire, Texas.

The Conservancy was in the final stages of contract negotiations with a food service company for the cafe and the ability to sell or not to sell beer and wine would impact the terms of the contract. The Conservancy was requesting the ability to sell and consume alcohol until 11:00 p.m. The proposed amendment did not have anything to do with the hours of operation for the cafe, but would impact the terms of their agreement with the potential cafe operator, as well as potential functions in the Event Center.

Director Miller advised further that the food service provider would be responsible for securing a permit from the Texas Alcoholic Beverage Commission, ensuring that the Conservancy and the City were properly insured, and that they complied with all laws and ordinances. He recommended that City Council support the Conservancy's request by amending Chapter 3, Article I, Section 3-3, of the Code of Ordinances of the City of Bellaire, Texas.

**Dr. Philip L. Nauert, Mayor**, offered an opportunity for members of the Conservancy to make comments. Patricia King-Ritter, President, and Lou Waters, Vice President, added comments regarding Evelyn's Park amenities and programming.

#### **Motion:**



#### **Item Title:**

Presentation, consideration of and possible action on a recommendation from the Bellaire Cultural Arts Board (BCAB) for a Pilot Utility Box Beautification Program - Submitted by Diane K. White, Assistant City Manager, on behalf of the Bellaire Cultural Arts Board.

#### **Background/Summary:**

Over the past year, the Bellaire Cultural Arts Board (BCAB) has considered the merits and feasibility of adopting an art program whereby the 5 City-owned utility boxes in Bellaire would act as a canvass and be tastefully decorated by a local artist. Utility painting programs are popping up all over the United States. Our neighboring City of Houston has implemented this program in many different neighborhoods including Meyerland.

#### **Pilot Program for Bellaire**

The BCAB requests that the City Council support our own "pilot project" starting with one of the City's five "utility boxes" located at the corner of S. Rice and Bellaire Blvd located within the Paseo Park at 7409 South Rice Ave. Streetlight signal and control box-H (66 ¼"),W (30 ¼"),D (24"). The cost of the program will be no more than \$1,000. The artist will be required to sign prerequisite agreement[s] regarding responsibilities/liabilities before final approval.

#### Rationale

This project is intended to introduce some artwork into the community through decorating an object that is otherwise quite unattractive, [albeit functional]. The artwork would be required to meet a "nature theme" and our initial thought is that it would complement the environment in which it is located. For example, it could reflect nearby plant-life and tastefully add a splash of color, perhaps reflecting morning glories or azalea bushes. The conceptual design will be agreed upon by the BCAB and the artist prior to painting. Depending upon the response to the initial artwork, the program could be extended to other utility boxes within the community. The BCAB will work closely and has consulted with Public Works Director Brant Gary on this project. The area would not be prepared and ready for painting until later this year.

#### **Item Title:**

#### **Background/Summary:**

On August 17, 2015, the Bellaire City Council held a public hearing for the proposed budget for the fiscal year beginning October 1, 2015, and ending September 30, 2016. The budget was then placed on the September 15, 2015 agenda and was approved by City Council. The adopted budget included a proposed tax rate of \$0.3805 per \$100 of valuation apportioned \$0.2501 for the General Fund and \$0.1304 for the Debt Service Fund. This proposed rate exceeds the lower of the effective rate or the rollback rate of \$0.3600 and \$0.3805, respectively. Because the proposed rate exceeds the effective rate, the City conducted two public hearings on October 6, 2015 and October 12, 2015. Based on the Certified Appraisal Roll from the Harris County Appraisal District received August 25, 2015, the 2015 total taxable value calculation for Truth-In-Taxation is \$4,520,573,580, and the total tax revenue that would be raised at the proposed tax rate of \$0.3805 per \$100 of valuation is \$17,200,782.

Attached for City Council review and approval is an ordinance setting the tax rate and tax levy for the City of Bellaire, Texas, for tax year 2015 (the fiscal year beginning October 1, 2015 and ending September 30, 2016) upon all taxable property in the City of Bellaire. This year's tax levy to fund maintenance and operations exceeds last year's maintenance and operations tax levy requiring the ordinance to include a statement about "tax increase" as specified in Section 26.05(b) of the Property Tax Code. This year's proposed total tax rate of \$0.3805 exceeds the effective tax rate. **The vote** on the ordinance setting the tax rate of \$0.3805 per \$100 valuation must be a record vote, and **the motion** to adopt the ordinance must be made in the following form stating the percentage by which the proposed tax rate exceeds the effective tax rate:

"I move that the property tax rate be increased by the adoption of a tax rate of \$0.3805, which is effectively a 5.7 percent increase in the tax rate."

#### **Item Title:**

Consideration of and possible action on the implementation of a retention incentive plan for each patrol officer and firefighter/paramedic employed by the City of Bellaire, including but not limited to a plan that would provide such employees a \$2,000 per year bonus payable at the end of each fiscal year, in recognition of the importance of and challenges inherent in keeping such positions filled and of the fact that many such employees travel significant distances to work - Requested by James P. Avioli, Sr., Councilman.

#### **Background/Summary:**

On September 15, 2015, Council voted to adopt the FY 2016 Budget. At that meeting, Councilman Avioli moved that the proposed budget be amended to "implement a retention incentive plan whereby each patrol officer for the City of Bellaire, Texas, would receive an additional \$2,000 per year as a mileage reimbursement (maximum mileage of 20 miles one way)." Following discussion among City Council regarding Councilman Avioli's proposal, Council voted to postpone consideration of the plan so that it could be evaluated by the City Manager and Police Chief, and to bring the motion back to Council no later than the second meeting in October.

Councilman Avioli's original plan was offered in recognition of the fact that Bellaire has for some years been experiencing a situation in which patrol officers are hired and trained by the City of Bellaire but depart for other employment opportunities after a relatively short period of time, sometimes for employment closer to their homes, which are located in more affordable areas, and/or for increased salary. The amended plan to be considered tonight includes firefighters/paramedics in the retention incentive plan as well, in recognition of the importance of likewise keeping our firefighters/paramedics ranks fully staffed, that two firefighters/paramedics have left Bellaire for other employment opportunities in the last year, and that many firefighters/paramedics likewise travel significant distances to work.

Councilman Avioli's \$2,000 per year plan is based on a hypothetical mileage reimbursement calculation, specifically an assumed 40-mile round trip for 5 working days per week and 50 weeks per year, reimbursed at a rate of \$.20 per mile  $(40 \times 5 \times 50 \times .20 = $2,000)$ . Assuming the current count of patrol officers (30) and firefighters/paramedics (21), the adoption of this plan would require \$102,000. Councilman Avioli recommends the adoption of this plan as an indication of the City's appreciation for the loyalty of our public safety employees in providing security to the residents of Bellaire.

This agenda item was drafted so as to allow consideration and discussion of alternative retention incentive plans in addition to that offered by Councilman Avioli.

A schedule of eligible police and fire staffing for the mileage incentive consideration is attached

hereto.

Police Retention and Recruiting

Bellaire City Councilmember Jim Avioli has proposed a stipend of \$2,000.00 to be paid annually to each Bellaire Police Officer to assist with commute cost. This is an earnest effort to assist with police officer retention and recruiting. I commend Councilmember Avioli for his innovative approach in addressing police retention and recruitment. With that said, I do not know if resources exist to fund this proposal and recommend other options be explored before this stipend is implemented.

Retention considerations include, but are not limited to:

- All employees will be leaving at some time for some reason. We just do not know when or why.
- The police work environment must motivate desirable and productive employees to stay.
- An employee must be provided opportunities for personal and professional development.
- When an employee does leave, we must have the capability to rapidly fill any vacancy with a quality applicant.
- Police Officers possess training, education, and experience which is in high demand by agencies through the Houston/Galveston metropolitan area more so than any other position. Bellaire must identify those items in which we can be directly compete as well as those items in which we cannot and identify alternative options to such.

Recruiting considerations include, but are not limited to:

- Promotion of a desirable work environment.
- Afford opportunities for personal and professional development.
- Applicants must perceive their training, education, and experience is recognized, valued, and will be rewarded by the City of Bellaire. The applicant must recognize the City of Bellaire has matching and competitive employment incentives or if not matching, alternative options to such.

The below listed items have been identified by police staff for evaluation and development.

#### Pay

- Communication Officers are to be placed within the Public Safety Pay Scale.
- All police employees within the Public Safety Pay Scale are to be moved to the 100 percentile. This can be accomplished in phases, starting at the 75 percentile.
- Increase longevity pay.
- Provide Shift differential pay.
- o Provide weekend differential pay.

#### Incentives

- Increase current Bellaire Police Department incentive pay for formal education, certification levels, and identified skills. An example of our non-competitive incentives are as follows;
  - Cypress Fairbanks ISD Police pay \$4,800.00 annually for TCOLE Master Certificate incentive, \$1,800.00 annually for bilingual incentive, and advanced education pay \$4,800.00
  - Bellaire Police pay \$2,002.00 annually for TCOLE Master Certificate incentive, \$754.00 or \$1,092.00 annually for bilingual incentive, and advanced education pay \$3,198.00 (PHD).
- Establish a relocation incentive up to \$2,000.00.

- Establish an academy reimbursement incentive up to \$2,000.00.
- Establish certificate incentive for Communication Officer licensing.
- Establish "milestone" incentives at the points in which an officer may be most likely to leave. For example, if we are most likely to lose officers at the 3 year point, then at the 3.5 year point officers that stay are entitled to a "milestone" incentive. This would be in the form of a special training opportunity or such.

#### Other

- Creation of four additional police officer positions to be filled within the next four fiscal years. This allows increases in demands for services to be addressed as well as the creation of assignment opportunities.
- Vacation days and holidays increased to market levels.
- Design and construct an innovated police building.
- Provide an annual \$500.00 equipment allowance. Current annual cost would be \$19,500.00.
- Increase tuition reimbursement.

I recommend that within 120 days these items are evaluated, prioritized, and cost projections completed. Within 180 days, a proposal for a planned implementation of selected items is developed for incorporation in the FY2017 budget. Some items may require a multi fiscal year implementation.

In a cost to hire study conducted by the Bellaire Police Department in 2014 it was shown that it cost between \$19,000-\$24,000.00 to recruit, hire, and train a police officer. There are currently five officers in the Field Training Program and one attending the police academy. This current training cycle will eventually account for approximately \$120,000.00 in tangible and intangible police resources.

These issues are market driven. The City of Bellaire must adopt, implement, as well as sustain a retention and recruiting philosophy for police officers. Such a philosophy can be that the City of Bellaire will maintain the status quo, as officers leave, Bellaire will continue to hire and train new officers. Alternatively, the philosophy can be that the City of Bellaire will be truly competitive and able to retain officers at a greater rate, but any vacancies are able to be rapidly filled.

SUBJECT: Mileage Incentive Proposal

Per your request, I have reviewed the "Proposal –Incentive Plan to Reduce Turnover" provided to City Council by Council Member Avioli and subsequently met and had discussions with the Police Chief and Fire Chief. We all certainly appreciate the heightened discussion around this. In consideration of the Assumption, Proposal, Budgetary Impact and Potential Benefit to the Police Force and to the City of Bellaire presented by Council Member Avioli, I respectfully offer additional information for consideration.

#### Assessment of Assumption:

- Over the past two years, three of 14 officers and one of four firefighters have left for closer commute. Of the three officers, one was employed for eight years, one for two years and one for one year. The one who was employed for two years also cited opportunity for promotion and growth at a larger agency as a reason for separation. Of the four firefighters, one was employed for one and a half years, one for two years, one for four years and one for 10 years. The most common reason to leave was opportunity and income potential.
- The average number of years of service for the officers who have separated in the last two years is 6.4 or 4.5 (without 32 year retiree).
- The average number of years of service for active officers is 4.75.
- Reasons officers leave vary; commute is not a majority factor.
- Five of the 14 separations have occurred since the new pay plan and premium pay were implemented for the following reasons:
  - 1 retiree
  - 1 relocation
  - 1 probationary performance related
  - 1 opportunity for promotion & growth at larger agency
  - 1 opportunity for promotion & growth at larger agency along with work & live in same community

#### Assessment of Proposal:

• Commuting to and from work is not a (non-taxable) reimbursable expense; therefore, a mileage compensation (incentive) plan would be taxable income. Assuming a 25% single rate tax bracket the incentive would be reduced from \$2,000.00 to \$1,500.00.

• The incentive would not apply to staff that have take-home vehicles (7) or motorcycle officers who receive an allowance and gas card (two)—total of officers. Nor would it apply to two fire officers who have take-home vehicles.

#### **Budgetary Impact:**

• The cost of the proposal would be \$60,000 annually based on \$2,000.00 for 30 officers. An additional \$16,800 would be needed to compensate 21 firefighters assuming two round trips per week at \$8.00 per day and 50 work weeks per year (\$800.00/yr. per firefighter). However, to these numbers we would also add Medicare, TMRS, Workers' Comp, Life Insurance, and Disability Insurance costs.

#### Potential Benefit to Police Force and the City of Bellaire:

 I believe there are other less divisive and broader incentive programs/opportunities that would allow for market competiveness and officers to know that Bellaire appreciates them for their loyalty in providing security to the citizens of Bellaire. Not to diminish the significance of public safety, there are other positions in the City that present a recruiting and retention challenge such as equipment operators and plant operators to which the proposed incentive plan would not apply, but could be justified.

Management Project 1601—Manage Turnover, Effectively Recruit & Fill Public Safety Positions Within this ongoing project, our plan is to implement full-cycle recruiting which includes casting a broad approach and evaluating many opportunities such as, but not limited to, assessing and improving existing incentives, exploring more internal learning and growth opportunities, reevaluating our pay and benefits philosophies including who (what cities), how (what are we comparing?) and at what level (50% or greater?) we compare ourselves. By using a comprehensive approach, we can build more effective strategies to thwart various reasons for undesired turnover resulting in extended vacancies and also compensate in ways that are mutually beneficial—to the employees and the City.

We have work to do; however, we are getting better. As an example of our progress, this time last year, October 2014, we had seven officer vacancies and one firefighter vacancy. Currently we have three officer vacancies and one firefighter vacancy. Together, we can find more practical, impactful and long-term ways of utilizing the resources Council would commit to this plan. As we brand ourselves as a premiere employer a lot goes into that—not the least of which is how we compensate employees. One specific idea is to effect base pay by making a policy decision to compensate public safety positions at the 75th percentile as soon as feasible, follow up with a plan to move all pay ranges to the 75th percentile, and maintain that position in the market. This is a dynamic continuous process to which we need to focus our attention. If the market calls for something different down the line, we need to be aware and prepared to make the adjustments.

I suggest that, within 120 days, we present recommendations for salary and incentive enhancements based on research and market based evidence. We are committed to maintaining our hiring standards, and want to encourage and reward the behaviors we want repeated. Again, we are working towards utilizing a comprehensive method of compensation that will align our compensation strategies with our business and service strategies which will be beneficial for all.

SUBJECT: Affordability of Incentive Retention Plan

The proposed FY 16 City of Bellaire general fund operating budget included a beginning balance of \$5.2 million. The beginning balance is a function of the projected ending balance for FY 15. The FY 15 projected ending balance is approximately \$888,710 greater than the amount originally budgeted for FY 15. This was reported in the 3rd Quarter Report, is the same projection used for the proposed FY 16 budget, and is explained below:

The adopted FY 16 general fund operating budget includes a budgeted ending balance of approximately \$4.0 million. The FY 16 ending balance assumes a \$5.2 million FY 16 beginning balance. The FY 16 Ending Balance, which was reduced by \$88,000 to fund the beautification line item, is \$1.0 million in excess of the City's 60 day reserve requirement.

The actual ending balance for FY 15 general fund operating budget is likely to be greater than the projected \$5.2 million. That difference, which we will report once we close FY 15, will show up in our FY 16 projections and will be available for future appropriations. That difference shouldn't be treated as a source for future recurring needs.

The estimated annual impact of the proposed Incentive Retention Plan is \$102,000. Funds exist for this additional FY 16 expenditure. That additional expenditure, however, will require a budget amendment at some point in the future to move current funds from the unappropriated ending balance to the departmental budgets that will incur the expense.

Attached is the fiscal forecast for the general fund as presented to the Council on July 20<sup>th</sup>. The forecast indicates unless we adjust our projections or assumptions, that we aren't achieving the ending balance requirement by FY 18.

I encourage the City Council to consider the long range implications of adding recurring expenses at this point in the fiscal year. Budgeting is about making choices. At some point decisions need to be made about the shortfalls projected in the fiscal forecast. Perhaps assumptions need to be amended; perhaps service levels need to be decreased.

Compensation decisions are important. 79% of our general fund operations budget is compensation and benefits. I recommend that compensation decisions be made with all of the necessary information about market conditions in front of us. We will have that necessary information before us in time for the Council's consideration of the FY 17 budget.
