Section 9. THAT the newly elected City official for the office of Councilman— Position No. 5 shall be administered the Oath of Office on November 16, 2015, and shall assume the duties of office immediately thereafter at the regular City Council meeting scheduled for November 16, 2016, all in accordance with the *Charter of the City of Bellaire, Texas,* as amended November 7, 2006.


