E. PUBLIC COMMENT

Johanna Moran-Ms. Moran informed the Commission that she was recently educated on the tree ordinances relating to residential new construction, specifically with regards to canopy. She added that it has come to her attention that some of the trees that are being saved are not desirable, and stated that the City should not be retaining these invasive species. Ms. Moran mentioned that she would like to see if the ordinance can be changed so that invasive plants are not propagated. She explained that she has had a conversation with Mr. McDonald, the Director of Development Services, and has provided him with a list of native trees and shrubs that can be substituted for some of the common, invasive plants that people now use. She informed the Commission that she would love to help in any way that she can.

Commissioner Baker asked for clarification on which type of tree she is specifically speaking of, and what she would like to see in place of it.

I. REPORT FROM THE BUILDING OFFICIAL

Mr. Davidson informed the Commission that the City is currently experiencing some slow down in new construction compared to this time last year. He stated that in this quarter of 2015 there were 29 new homes going up, whereas this year there are only 15. Mr. Davidson also mentioned that there is no additional news to report regarding the food damaged homes, and that the City is still waiting to hear back on the grant money. He also informed the Commission that there is a substandard structure that he has begun the process on. He added that he has reached out to the owner of record and is waiting on their response. Mr. Davidson stated that if there is no response and/or the City cannot reach an agreement with the owner then it will be brought before the Commission.

Mr. Davidson stated that it is vacant, and is simply being used for storage.

Commissioner Baker asked what the address was.

Mr. Davidson informed the Commission that it is 5122 Patrick Henry.

Vice Chairman Spencer asked how the City was doing, commercially.

Mr. Davidson stated that Condit Elementary is on schedule to open for the first day of school. He added that Episcopal High School's project is coming along and that there is a middle school that is currently redoing their entry way. Mr. Davidson informed the Commission that lease space built outs are continuing like normal. He also mentioned that there are several businesses relocating from the HEB shopping center.

Commissioner Martin asked what the status is on construction of the new HEB.

Mr. Davidson explained that they changed some things with their site plan and therefore had to go back before the Planning and Zoning Commisson to amend their Planned Development.

Commissioner Martin asked when they would begin demolition.

Mr. Davidson stated that an exact date has not been communicated, and that it will ultimately depend on the outcome of the requested amendment to the planned development.

Commissioner Baker provided Mr. Davidson with four more properties to look into possibly being substandard.
