Environmental and Sustainability (ESB) Board Meeting Wednesday, February 1, 2017 Bellaire City Hall Council Conference Room

Meeting Minutes

A. Opening

The regular meeting of Environmental and Sustainability Board (ESB) was called to order at 6:43PM on Wednesday, February 1 2017, by Jason Wintz, Chairman. There was a quorum of members present.

B. Public Works Update:

- 1. Paul Hofmann, City Manager, updated the Board on several items:
 - a. The City is making good progress in the search for a replacement for Brant Gary, who has departed Bellaire for Fulshear TX. As the search for a new PW Director continues, Paul noted that he is seizing the opportunity to get much closer to and more hands-on with employees in Public Works.
 - b. Paul also updated the Board on many of the bond issue projects that are now underway. He said that in the near future all Bellaire water meters will be replaced; an \$8 million update will be completed on the waste water treatment plant; much will be accomplished in street repair and in sidewalk improvements.
 - c. George Williams asked about a tour of the waste water treatment plant, and both Paul and Shawn Cox encouraged all Board members to schedule such a tour (preferably before hot weather makes that tour a little less enjoyable!).
 - d. Paul also advised the Board that the City is developing longer range plans that may involve new bond issues in coming years.

C. Approval of Minutes: The minutes of the Board meeting of January 4 2017 were approved unanimously.

D. Board Business:

- a. Review and Approval of the Board's Update to City Council for 2016: a draft copy of the presentation to Council scheduled for February 6 was attached to the agenda that was distributed by Shawn Cox prior to the meeting. There was much discussion and several edits of the presentation content, and Shawn stated that any further suggested edits need to be submitted to him before midday February 2, as the Council packages will go to print on February 2.
- b. Review and Approval of recommended Facebook posts: Included in the Board package were several (18) recommended posts. After some discussion, 16 were approved, unanimously, with the proviso that all of the posts appear with the headline "Recycling Makes A Difference." The only posts scratched from the list were two that addressed recycled cell phones in 2003 and 2004. The Board agreed that the information may no longer be relevant. George Williams will continue the work to get the posts on the Bellaire Facebook page.
- c. NDC Spring Fling Participation: Shawn Cox advised the Board that the NDC Spring Fling has been canceled for 2017, due to construction at the NDC location. Jason asked Ayo Bello to investigate the proposed NDC "Reveal" event and see if there is a possibility for ESB participation.
- d. Discussion of Audubon's promotion of "Bird-Friendly Communities:"
 Included in the Board package was a document titled "Why Native Plants are Better for Birds and People." Johanna Moran suggested that this might be added to the Facebook posts. George Williams and Shawn Cox both advised that any post of research material or findings must be from a .gov or .edu source to qualify for the city website. It was agreed that Johanna and Ayo will draft a letter to be considered by the Board for presentation to City Council requesting Council action to prohibit the planting certain species of invasive trees

H. New Business -

- a. George Williams called the Board's attention to an article he saw that appeared in an El Paso newspaper addressing possible violations of the Texas Open Meeting law. George suggested that all Board members might want to find and read this article, and then pay heed to its message.
- b. Semi-annual Bellaire Recycling Drop-Off Event: After some discussion of possible dates for the next event, it was agreed that Ayo will contact the recycling vendors to determine their availability for the dates of May 6 and May 13.

I. Adjournment --

There being no further business, the meeting was adjourned at 8:23PM. The next regularly scheduled meeting will be held on March 1 2017.

Holiday Recycling Tips:

Reuse Gift Wrapping

Did you know that shiny wrapping paper is not recyclable? Use cool wrapping materials. Reuse maps, the Sunday comics, and posters. Wrap gifts without a box. And remember to save ribbons, bows and bags to reuse next year.

Use Reusable Dishware

Avoid using disposable dishes and utensils when entertaining friends and family, and if you must use them, buy them made from recycled or compostable material.

Use Energy-Efficient Lighting

When decorating, use Energy Star energy efficient lighting such as LED outdoor holiday lights, which require 1/50th of the electricity of conventional lights and last 20-30 years. Put lights on a timer or turn them on only when someone's home.


